REGULATION

on the organization of the promotion exam for obtaining the professional degrees CSIII, CSII and CSI within the "Nicolae Simionescu" Institute of Cellular Biology and Pathology of the Romanian Academy

Approved,

Section of Biological Sciences of the Romanian Academy

Chapter I. General Provisions

Article 1.

The scientific career development of the research and development staff employed at the Institute of Cellular Biology and Pathology "Nicolae Simionescu" (ICBP-NS) of the Romanian Academy is ensured and carried out through promotion to the next higher professional grades.

Article 2.

Promotion is carried out through an examination organized in accordance with the provisions of Law 53/2003 on the Labor Code, Law 183/2024 on the Status of Research, Development and Innovation (RDI) personnel, Order of the Ministry of National Education and Scientific Research no. 6129/20.12.2016, the Methodological Norms on the organization of the promotion examination for obtaining higher professional research grades issued by the Romanian Academy on July 15th, 2025, and in accordance with this regulation.

Article 3.

This Regulation includes the methodology regarding the organization of the promotion examination for obtaining higher professional research grades: CSIII, CSII, and CSI at ICBP-NS.

Article 4.

Promotion to professional grades of already employed RDI personnel is carried out by transforming the occupied position into an immediately higher position, corresponding to the professional grade obtained through the examination.

Article 5.

Scientific researchers at ICBP-NS are differentiated by functions and professional research and development grades, maintaining equivalence with the professional grades provided in the European Charter for Researchers, as follows:

- (i) Scientific Researcher Grade I (CSI), equivalent to Principal Senior Researcher R4, holding a PhD;
- (ii) Scientific Researcher Grade II (CSII), equivalent to Established Senior Researcher R3, holding a PhD:
- (iii) Scientific Researcher Grade III (CSIII), equivalent to Recognized Researcher R2, holding a PhD;
- (iv) Scientific Researcher (CS), equivalent to Junior Researcher R1, holding a PhD or being a PhD student:
- (v) Assistant Scientific Researcher (ACS), equivalent to Assistant in Scientific Research, holding a Bachelor's degree.

Article 6.

The number of RDI positions financed by the annual State Budget Law is established annually by the Romanian Academy, which will allocate the budget line accordingly and with the approvals of the Ministry of Public Finance.

Article 7.

The promotion examination is organized at the decision of the ICBP-NS management, depending on available financial resources and human resources policy, within the approved budgets and in compliance with legal provisions.

Article 8.

Employment in RDI positions is carried out through competition/examination, which is organized based on the following principles:

- **a.** the principle of transparency, competence, gender equality, non-discrimination, and equal and fair access to filling vacant positions and promotion to a higher professional grade;
- **b.** the principle of ensuring the quality and professional training of research staff;
- **c.** correct and complete information regarding the organization and conduct of competitions/promotion examinations;
- **d.** transparency regarding administrative, financial, and evaluation information of research positions in accordance with current legislation.

Chapter II. Minimum Training Conditions

Article 9.

The promotion examination is organized at the decision of the ICBP-NS management, following the request of the person who meets the provisions of Law no. 183/2024 regarding the necessary

conditions for registration, paragraphs (10) and (11), and the minimum standards specific to each scientific field, paragraph (1); as well as the additional standards established within the Institute of Cellular Biology and Pathology "Nicolae Simionescu" of the Romanian Academy (Annex SC).

Article 10.

The criteria on which the minimum standards for occupying the functions and professional grades of the RDI staff from ICBP-NS are based are as follows:

- a. results of research and/or innovation activity;
- **b.** impact of research and/or innovation activity;
- **c.** ability to attract research funds or to collaborate with public and/or private research organizations;
- d. professional prestige;
- e. organizational capacity;
- **f.** capacity for international cooperation.

Article 11.

The minimum standards for the professional research-development grades established by the Romanian Academy are:

- (1) For the professional grades CSII and CSI, the minimum standards are approved by order of the Minister of Education;
- (2) For the professional grade CSIII, the minimum standards are:
- a. to hold a doctoral degree in the specialty or in related fields;
- **b.** at least five articles published in journals indexed in the Web of Science Core Collection;
- c. at least one paper presented at an international conference.

Article 12.

The additional necessary and mandatory minimum standards established by ICBP-NS for the evaluation of candidates' professional activity are presented in Annex SC of the Procedure regarding the recruitment, selection, and promotion of RDI staff. These are established and approved by the Scientific Council of ICBP-NS and do not derogate from the minimum standards provided by law.

Article 13.

Scientific researchers CS, CSIII, and CSII, who exceed by at least 50% at least two-thirds of the institute's own minimum standards, provided in Article 12, may take the examination for promotion to the next professional grade within ICBP-NS of the Romanian Academy, with which they have an indefinite-term individual employment contract, and may be promoted by signing an additional act to the existing individual employment contract. All the minimum standards included in the annex provided for in Article 12 must be met, and two-thirds of the institute's own minimum standards, whichever they may be, must be exceeded by at least 50%.

Chapter III. Conduct of the Examination

Article 14.

The calendar for conducting examinations at ICBP-NS, for filling vacant positions, is as follows: **a.** the application for registration to the examination is drawn up and submitted for approval to the Scientific Council of ICBP-NS (Annex 1P);

b. registration for the examination and submission of the examination file is carried out within a

maximum of 30 calendar days, according to the schedule in the announcement for the promotion examination, published on the institute's website;

- **c.** decisions are drawn up with the composition of the examination/appeals commissions and the designation of the commission president;
- **d.** the examination files are submitted to the president of the examination commission, after being previously registered and verified by the secretary of the examination commission, for analysis;
- **e.** the entire examination procedure must be completed within 15 days from the closing date of registration, at the level of the examination commission, and within 45 days from the submission of the commission's report and file to the Presidium of the Romanian Academy;
- **f.** within a maximum of 2 days from the communication of the result, candidates have the right to file an appeal;
- **g.** within a maximum of 2 working days from the completion of the examination, the final result of the examination is communicated.

Article 15.

Members of the examination commission are scientific researchers or university teaching staff with a professional grade or university teaching title at least equal to the professional grade for which the examination is organized. The work of the examination commission is led by one of its members, as president, appointed by decision of the Director of ICBP-NS. The composition of the commission is:

- **a.** 3 members, in the case of the examination for CS and CSIII;
- **b.** 5 members, of which at least 3 are from outside ICBP-NS, for CSII and CSI.

Article 16.

The promotion examination for obtaining the professional grades of CSIII, CSII, and CSI consists of:

- **c.** analysis of the application file for the examination, which must contain the documents provided in Annex DP (only the standard forms approved by ICBP-NS according to this Regulation will be used: Annexes 1P–5P, drawn up according to the models proposed in the Methodological Norms on organizing the promotion examination for obtaining professional grades of RDI staff in institutes of the Romanian Academy / July 15, 2025);
- **d.** verification of compliance with the conditions provided in Articles 11 and 12;
- e. awarding of scores based on evaluation according to the annex provided in Article 12.

Article 17.

The results of the evaluation process are recorded by each member of the examination commission in an assessment report (Annex 2E), on the basis of which the president of the examination commission prepares a report on the examination, signed by each member, and proposes the granting of the professional research-development grade to the respective candidate.

Article 18.

The Scientific Council analyzes compliance with the procedures established by the regulation and approves or rejects the examination report, by open nominal vote.

Article 19.

Candidates dissatisfied with the examination result may submit appeals, which will be resolved within 2 working days from their registration, by the appeals resolution commission, composed of: **a.** president and 2 members, scientific researchers or university teaching staff, in the case of

commissions for resolving appeals submitted following examinations for filling research execution positions;

b. 3 members, namely one member from the specialized section of the Romanian Academy, Section of Biological Sciences, who is also the President of the commission, and 2 members from ICBP-NS holding CSI grade, in the case of commissions for resolving appeals submitted following examinations for filling research management positions.

c. the secretary of the appeals resolution commission will be appointed from within ICBP-NS by decision of the Director of ICBP-NS.

Article 20.

The examination commission and the appeals resolution commission benefit from administrative support from the research organization, provided by a secretary appointed by administrative act of the head of the research organization, who is not a member of the commission and does not take part in the commission's decisions. The standard forms used by the members of the commissions will be those proposed and approved in accordance with this Regulation (Annexes 1E and 2E, drawn up according to the models proposed in the Methodological Norms on organizing the promotion examination for obtaining professional grades of RDI staff in institutes of the Romanian Academy / July 15, 2025).

Article 21.

The promotion examination files for obtaining the professional grades of CSIII, CSII, and CSI are submitted by ICBP-NS within 10 calendar days from the completion of the examination to the Section of Biological Sciences of the Romanian Academy.

Chapter IV. Results of the Examination and Appointment to the position

Article 22.

Following the approval of the favorable examination result conducted at ICBP-NS by the Presidium of the Romanian Academy, the President of the Romanian Academy issues the decision for employment and granting of the professional research-development grade of CSIII, CSII, or CSI to the promoted candidate, in accordance with the provisions of Article 10 of Law no. 183/2024.

Article 23.

After the approval of the results of the promotion examination by the Presidium of the Romanian Academy, the file is returned to ICBP-NS.

Article 24.

Under the conditions of Article 4, if the researcher passes the examination, they will be employed in the position corresponding to the professional grade obtained through the examination, by signing an additional act to the existing individual employment contract. The position corresponding to the higher research grade resulting from the transformation of the position previously held by the person before promotion will be budgeted no later than the year following the one in which the promotion took place, and the additional act to the individual employment contract will be concluded starting no later than January 1 of the year following the one in which the promotion examination was passed, based on the decision issued by the Romanian Academy.

Article 25.

Employment in positions corresponding to the functions and professional grades of RDI staff is carried out according to the principle of professional merit, based on transparent and fair procedures that respect the general principles and conditions provided by the European Charter for Researchers.

Article 26.

The equivalence of university teaching functions with the functions and professional RDI grades within ICBP-NS applies only with the approval of the Scientific Council, after the evaluation of the additional standards adopted at ICBP-NS.

Article 27.

The personal data of individuals involved in the examination process are processed within the information platform, in compliance with the provisions of Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

Article 28.

A summary report on the organization and conduct of the promotion examination is prepared at the level of ICBP-NS by the human resources officer and submitted annually, within 15 calendar days from the end of the calendar year for which the reporting is made, both in physical format with a forwarding address, to the Research and Doctoral Programs Service, and in electronic format to the email address bpg@acad.ro.

Article 29.

Annexes DP, L, 1P–5P, 1E, and 2E form part of this Regulation and, together with it, were established and drawn up by ICBP-NS in accordance with the regulations and models proposed by the Romanian Academy in the Methodological Norms on organizing the promotion examination for obtaining professional grades of RDI staff in institutes of the Romanian Academy / July 15, 2025.

The present Regulation was approved in the meeting of the Scientific Council of ICBP-NS on August 7, 2025. It may be adjusted based on the calibration provided by the examinations for each category (scientific degree) that will take place subsequently.

Minimum Standards of the "Nicolae Simionescu" Institute of Cellular Biology and Pathology for the Award of Professional Grades

The filling of research, development, and innovation (RDI) positions within the "Nicolae Simionescu" Institute of Cellular Biology and Pathology (ICBP-NS) is carried out either through a competition organized for a vacant position, or through an examination for promotion to a higher professional grade than the one currently held.

In order to participate in the competitions organized by ICBP-NS for filling vacant RDI positions, candidates must mandatorily meet the legal minimum standards (according to Law 183/2024 and the Minister's Order no. 6129/2016 on the status of RDI personnel), as well as the additional internal standards established and approved by the Scientific Council of ICBP-NS.

For promotion, only scientific researchers (CS, CSIII, and CSII) with permanent employment contracts who exceed by at least 50% at least two-thirds of ICBP-NS's own minimum standards may take the examination for promotion to a higher professional grade within ICBP-NS. Promotion is carried out through the conclusion of an addendum to the existing employment contract.

1. Minimum ICBP-NS Standards for Awarding the Professional Grade of CSI

Scientific Researchers **CSII**, who have permanent employment contracts, may take the exam for promotion to a higher professional grade within ICBP-NS, provided that they meet the following criteria:

- fulfill all 4 minimum standards under Criteria 1–4;
- exceed by at least 50% at least three of these four minimum standards.

Promotion is carried out through an addendum to the existing employment contract.

Criterion 1. Scientific articles published after the PhD, as main author

Minimum standard: The candidate must have published, after obtaining the PhD title, at least **4 articles** in ISI-indexed journals, with a cumulative AIS* of at least 4, where the candidate appears as main author (first author, corresponding author, or last author, as applicable).

For promotion (\geq 50% above standard): At least 6 ISI-indexed articles, with a cumulative AIS* \geq 6, where the candidate is main author.

Criterion 2. Scientific articles published in the last 5 years, as main author

Minimum standard: The candidate must have published, in the last 5 years, at least 2 articles in ISI-indexed journals – each article with an AIS* of at least 0.5 – in which the candidate appears as main author (first author, corresponding author, or last author, as applicable).

For promotion (exceeding the standard by at least 50%): The candidate must have published, in the last 5 years, at least 3 articles in ISI-indexed journals – each article with an AIS* of at least

0.5 – in which the candidate appears as main author (first author, corresponding author, or last author, as applicable).

*Note:

- -AIS (Article Influence Score), according to https://jcr.clarivate.com/ for the year of publication; for articles published before 2007, the AIS value from 2007 will be used. If the classification for the year of publication is not available, the most recent available classification will be considered.
- -The AIS value for mandatory preliminary conditions is divided according to the formula: AIS/pi, where pi = 1 when the article has 1, 2, or 3 main authors (defined as first, last, and corresponding), or equals the number of main authors when there are more than 3.
- -At least 50% of published scientific articles must be listed in Web of Science under the category "document type: article". This percentage does not include works classified as "review" or multiple combinations such as "Article; Proceedings Paper", "Article; Book Chapter", etc

Criterion 3. Coordination of research projects/grants obtained after the PhD

Minimum standard: The candidate must have coordinated, after obtaining the PhD degree, at least two research projects/grants, national or international, in one of the following variants:

- two projects (national or international), as Project Director or Partner Coordinator, or
- one national project and one international project (as Director or National Coordinator).

Note: For at least one of these projects, the coordinated research team must include a minimum of 3 members.

For promotion (exceeding the standard by at least 50%): The candidate must have coordinated, after obtaining the PhD degree, at least three research** projects/grants, national or international, in one of the following variants:

- 3 research projects/grants (national or international), as Project Director or Partner Coordinator, or
- 2 national projects and 1 international project (as Director or National Coordinator), or
- 1 national project and 2 international projects (as Director or National Coordinator).

Note: For at least one of these projects, the coordinated research team must include a minimum of 3 members.

**Note:

- -Projects must be obtained either: (1)through national or international competition (in which case a link to the competition page or other documents proving the competition must be provided), or through non-competitive allocation, provided the project budget is at least €50,000.
- -Projects that do not include logistics expenses, grants funded by the candidate's own institution, or grants for congress participation will not be considered.

-Projects must be carried out in an institution with research and development activities.

Criterion 4. Quantification of Scientific Activity

Minimum standard: Total score obtained based on the calculation of indicators from Table 1: 500 points $\Sigma 1-2$ and 600 points $\Sigma 1-18$.

For promotion (exceeding the standard by at least 50%): Total score obtained based on the calculation of indicators from Table 1: 750 points $\Sigma 1$ –2 and 900 points $\Sigma 1$ –18.

2. ICBP-NS Minimum Standards for the Award of the Professional Grade of CSII

Researchers holding the title of Scientific Researcher III (CS III), with an individual employment contract of indefinite duration, may apply for promotion to a higher professional grade within ICBP-NS, provided that they meet the following criteria:

- they meet all three minimum standards set out in Criteria 1–3;
- they exceed by at least 50% at least two of the three minimum standards.

Promotion is carried out by signing an addendum to the existing individual employment contract.

Criterion 1. Scientific Articles Published after PhD, as Main Author

Minimum standard: The candidate must have published, after obtaining the PhD degree, at least 2 scientific articles in ISI-indexed journals, as main author, which must meet the following conditions:

- The cumulative AIS* of the two articles must be at least 2.
- At least one article must have been published in the last 5 years, with an AIS of at least 0.4*.

For promotion (exceeding the minimum standard by at least 50%): The candidate must have published, after obtaining the PhD degree, as main author:

- At least 3 articles in ISI-indexed journals, with a *cumulative AIS** of at least 3*;
- At least 2 articles must have been published in the last 5 years, each with an AIS* of at least 0.4*.

*Note:

- -The AIS (Article Influence Score), according to https://jcr.clarivate.com/ from the year of publication; for articles published before 2007, the AIS value from 2007 will be used. If the classification from the year of publication is not available, the most recent available classification will be considered.
- -The AIS value for the mandatory preliminary conditions is divided according to the formula: AIS/pi, where pi = 1 when the article has 1, 2, or 3 main authors (first, corresponding, and last author), or equals the number of main authors if there are more than 3.
- -At least 50% of the published scientific articles must be indexed in Web of Science with the classification "document type: article." This percentage does not include works classified as "document type: review" or multiple combinations such as: "Article; Proceedings Paper," "Article; Book Chapter," etc.

Criterion 2. Coordination of Research Projects/Grants** Obtained after PhD

Minimum standard: After obtaining the PhD degree, the candidate must have coordinated at least one research project or grant (national or international) as project director or partner responsible.

For promotion (exceeding the minimum standard by at least 50%): The candidate must have coordinated at least two research projects or grants (national or international as project director or partner responsible).

- -Projects must be obtained: (1)through national or international competition, the link to the competition webpage or other documents proving the competition must be provided, (2)through direct award, non-competitive, in which case the project budget must be equivalent to at least $\[\in \]$ 50,000.
- -Projects without logistical expenses, grants financed by the candidate's own institution, or grants for congress participation will not be considered.
- -Projects must be carried out within an institution conducting research and development activities.

Criterion 3. Quantification of Scientific Activity

Minimum standard: Total score obtained based on the calculation of the indicators in Table 1:300 points $\Sigma 1$ –2 and 450 points $\Sigma 1$ –18

For promotion (exceeding the minimum standard by at least 50%): Total score obtained based on the calculation of the indicators in Table 1: 450 points $\Sigma 1-2$ and 675 points $\Sigma 1-18$

3. ICBP-NS Minimum Standards for Awarding the Professional Title of CSIII

Scientific Researchers (CS) with an indefinite-term individual employment contract may take the examination for promotion to a higher professional grade within ICBP-NS, provided they meet the following criteria:

- they must fulfill all three minimum standards specified under Criteria 1–3;
- they must exceed by at least 50% at least two of the three minimum standards.

Criterion 1. Scientific articles published

Minimum standard: The candidate must have published at least 5 scientific articles in ISI-indexed journals, either as principal author or co-author.

For promotion (by exceeding the minimum standard by at least 50%): At least 8 ISI-indexed articles must be published, as principal author or co-author.

Criterion 2. Scientific articles published with a cumulative AIS of at least 2

Minimum standard: The candidate must have published **at least 2 articles** in ISI-indexed journals, with a cumulative AIS* of at least 2.

For promotion (by exceeding the minimum standard by at least 50%): The candidate must have published at least 3 articles in ISI-indexed journals, with a cumulative AIS* of at least 3.

- -The AIS (Article Influence Score) factor is taken from https://jcr.clarivate.com/ for the year of publication. For articles published prior to 2007, the 2007 AIS value shall be used. If the classification for the publication year is not available, the most recent available classification will be taken into consideration.
- -The AIS value for mandatory preliminary conditions is fractionalized according to the formula: AIS/pi, where pi = 1 if the article has 1, 2, or 3 principal authors (namely the first author, the last author, and the corresponding author), or equals the number of principal authors if there are more than 3.
- -At least 50% of the scientific articles published must be listed in Web of Science under the "document type": "article". This percentage does not include works categorized as "document type": "review" or multiple combinations such as "Article; Proceedings Paper", "Article; Book Chapter", etc.

Criterion 3. Quantification of scientific performance

Minimum standard: Total score resulting from the calculation of the indicators in Table 1: **100** points Σ_1 -2 and **150** points Σ_1 -17.

For promotion (by exceeding the minimum standard by at least 50%): Total score resulting from the calculation of the indicators in Table 1: 150 points Σ 1-2 and 225 points Σ 1-17.
